Eligible entrants	Any person aged 18 years or older. Any person who is barred or self-excluded from any area of Village Belle Hotel are not permitted to enter this promotion. Directors, management and employees of the Promoter and their immediate family are not permitted to enter this promotion.
Purchase of Product	For each food or beverage item purchased in the Public Bar and Garden Bar during the Promotion Period, the purchaser will receive one entry ticket into this Promotion.
